SUBJECT: STIPEND AWARDS TO THE CHILDREN OF FEDERAL GOVERNMENT EMPLOYEES FOR THE YEAR 2023-24.

Reference this office earlier Circulars of even number dated 31-08-2023 and 31-10-2023 on the subject noted above, It is clarified that the children of Federal Government Employees studying in any Educational Institutions whose ownership rest with Federal or Provincial or any Authority/ Organization/ Department are also eligible for grant of Stipend from Staff Welfare Organization. As a result the children Federal Government Employees studying in the following Educational Institutions became eligible for Grant of Stipend from Staff Welfare Organization.

- i) Educational Institutions setup by Army/ Navy and Airforce.
- ii) Educational Institutions setup by ASF,CDA or OPF.
- iii) Educational Institutions run/controlled by the District Administration.
- iv) Educational Institutions setup/controlled by Federal or provincial Ministries.

2. The Federal Government Employees whose children are studying under the above education institutions are also encouraged to apply.
